State of Missouri vs.

John Gadwood,

Now comes W. W. Graves, Prosecuting Attorney for the State of Missouri, in and for the body of the County of Jackson, and upon his oath informs the Court, that John Gadwood, whose Christian name in full is unknown to said W. W. Graves, Prosecuting Attorney, on the 27th day of March, 1934, at the County of Jackson and State of Missouri, in and upon one Lee Flacy, then and there being, feloniously, willfully, deliberately, premeditatedly, on purpose and of his malice aforethought, did make an assault, and a certain Pistol and Shotgun, which were then and there loaded with gunpowder and leaden balls, and by him the said John Gadwood, in his hands then and there had and held, he the said John Gadwood did then and there feloniously, willfully, deliberately, premeditatedly, on purpose and of his malice aforethought, discharge and shoot off at, upon and against him, the said Lee Flacy, and he the said John Gadwood, with the leaden balls aforesaid, out of the Pistol and Shotgun aforesaid, then and there, by force of the gunpowder aforesaid, by the said John Gadwood shot off and discharged as aforesaid, then and there, feloniously, willfully, deliberately, premeditatedly, on purpose and of his malice aforethought, did strike, penetrate and wound the said Lee Flacy, in and upon the Body of him the said Lee Flacy, thus and thereby, then and there feloniously, willfully, deliberately, premeditatedly, on purpose and of his malice aforethought, giving to him the said Lee Flacy, with the leaden balls aforesaid, so, as aforesaid, discharged and shot off out of the Pistol and Shotgun aforesaid, by the said John Gadwood, mortal wounds, of which said mortal wounds the said Lee Flacy, from the said 27th day of March, in the year aforesaid, until the 27th day of March, in the year aforesaid, did languish and languishing did live, on which said 27th day of March, in the year aforesaid, the said Lee Flacy, at the County of Jackson and State of Missouri, of the mortal wounds aforesaid, died; and so the W. W. Graves, Prosecuting Attorney aforesaid, upon his oath aforesaid, doth say, that the said John Gadwood, him the said Lee Flacy, at the County aforesaid, in the manner and by the means aforesaid, feloniously, willfully, deliberately, premeditatedly, on purpose and of his malice aforethought, did kill and murder; against the peace and dignity of the State.
