WARRANT TO APPREHEND

The President of the United States of America,

TO THE MARSHAL OF THE UNITED STATES FOR THE WESTERN DISTRICT OF MISSOURI AND TO HIS DEPUTIES, OR ANY OR EITHER OF THEM:

WHEREAS, Martin J. Lahart, Special Agent, has made complaint in writing under oath before me, the undersigned, a United States Commissioner for the Western District of Missouri, Western Division, charging that Link Moran and Frank Hart, Pat Noonan, Joe School, Charles Binagio, Milan Bevis, Glenn White, Eddie Moran, Silas Counts, late of Jackson County, in the State of Missouri did, on or about the 8th day of September A. D. 1932, at "White House Tavern", now known as "Kit Kat Nite Club", 82nd and Troost, in said District, in violation of Sections 3 and 21, Title II of the National Prohibition Act, of the United States, unlawfully possess and sell intoxicating liquors and maintain a nuisance.

That on September 8, 1932, at 11:00 p.m. I, in company with Prohibition Investigator Leo C. Krayer, visited the White House Tavern, where I purchased six whiskey highballs from Silas, a negro waiter, last true name unknown but described as age 35 years, height 5' 10", hair straight black, high forehead, weight 185 pounds, very black, paying him the sum of \$2.10. Frank Hart sat at our table and called Silas. Hart instructed him to bring some highballs. Hart stated he was working there and as each party entered the place he went to the door and greeted them. There were about forty people present at the time of my visit and at three tables I saw highball glasses. At the other tables beer was served.

NOW, THEREFORE, YOU ARE HEREBY COMMANDED, in the name of the President of the United States of America, to apprehend the said Link Moran and Frank

Hart, Pat Noonan, Joe_School, Charles Binagio, Milan Revis, Glenn White, Eddie Moran, Silas Counts, wherever found in your District and bring their bodies forthwith before me or any other Commissioner having jurisdiction of said matter, to answer the said complaint, that he may then and there be dealt with according to law for the said offense.
