## INDICTMENT

The grand jurors of the United States of America, duly and legally chosen, selected, summoned and drawn from the body of the Western District of Missouri, and duly and legally empanelled, sworn and charged to inquire of and concerning crimes and offenses against the United States of America in the Western District of Missouri, upon their oaths present and charge that one Anthony Cassata whose name other than as herein set forth is to the grand jury unknown did on the 30th day of August, 1933, at the Public Library at Ninth and Locust Streets in Kansas City, Jackson County, Missouri, in the Western Division of the Western District of Missouri, unlawfully, wilfully, knowingly and feloniously sell to one William Wells and Margaret Wells, twelve (12) grains of morphine hydrochloride a derivative of opium, not from the original stamped package and not in the original stamped package, and upon which the tax had not been paid as is required by law;

Contrary to the form of the statute in such case made and provided, and against the peace and dignity of the United States of America.

COUNT II.

And the grand jurors aforesaid, upon their oaths aforesaid, do further present and charge that one Anthony Cassata whose name other than as herein set forth is to the grand jury unknown, did on the 30th day of August, 1933, at the Public Library at Ninth and Locust Streets, in Kansas City, Jackson County, Missouri, in the Western Division of the Western District of Missouri, unlawfully, wilfully, knowingly, feloniously and fraudulently receive, conceal, buy and sell and facilitate the transportation, concealment and sale after importation of a certain derivative and preparation of opium, towit: 12 grains of morphine hydrochloride which had theretofore been unlawfully imported and brought into the United States, and that he, the said Anthony Cassata then and there well knew that the said morphine hydrochloride had been so unlawfully imported and brought into the United States: Contrary to the form of the statute in such case made and provided, and against the peace and dignity of the United States of America.

COUNT III.

And the grand jurors aforesaid, upon their oaths aforesaid do further present and charge that one Anthony Cassata whose name other than as herein set forth is to the grand jury unknown, did on the 2nd day of September, 1933, at the Pickwick Bus Station, Ninth and McGee Streets, in Kansas City, Jackson County, Missouri, in the Western Division of the Western District of Missouri, unlawfully, wilfully, knowingly and feloniously sell to one Margaret Wells, 242 grains hydrochloride, of morphine hydrochloride a derivative of opium not from the original stamped package and not in the original stamped package and upon which the tax had not been paid as was required by law: Contrary to the form of the statute in such case made and provided, and against the peace and dignity of the United States of America.

COUNT IV.

And the grand jurors aforesaid, upon their oaths aforesaid, do further present and charge that one Anthony Cassata whose name other than as herein set forth is to the grand jury unknown, did on the 2nd day of September, 1933, at the Pickwick Bus Station, Ninth and McGee Streets, in Kansas City, Jackson County, Missouri, in the Western Division of the Western District of Missouri, unlawfully, wilfully, knowingly, feloniously and fraudulently receive, conceal, buy and sell and facilitate the transportation, concealment and sale after importation of a certain derivative and preparation of opium, towit: 242 grains of morphine hydrochloride which had theretofore been unlawfully imported and brought into the United States, and that he , the said Anthony Cassata, then and there well knew that the said morphine hydrochloride had been so unlawfully imported and brought into the United States: Contrary to the form of the statute in such case made and provided, and against the peace and dignity of the United States of America.
