Attached hereto are certificates from Dr. T. S. Blakesley, Dr. Ralph F. McKinney and Dr. Anthony J. Scimeca, which state that the defendant is in poor physical condition and that incarceration in jail will endanger his life. An investigation by the United States Probation Officer reveals that this defendant has no previous record and that he is a feeble and sick man and confinement in jail is detrimental to his health.

IT IS HEREBY ORDERED that the United States Marshal release said Frank Balestrere from imprisonment on the 6th day of January, 1934. Defendant Balestrere is placed on probation for a period of years on the usual conditions of probation. He is ordered to report to the office of the United States Probation Officer upon his release.

To Whom It May Concern:

This is to cerify that I examined Mr. Frank Balestrere and the following constitutes a summary of my findings.

Man giving age as 57, (quite plethoric but poorly nourished and appearing to be considerably older than he is, complains chiefly of a marked tachycardia, dyspnea, a feeling of a weight in the epigastric region, malaise, hypochondriasis, annorexia, and a general indisposition to mental and physical exertion.

Physical Examination Reveals the Following:

A moderate alopecia, features pinched and anxious, skin is markedly jaundiced with mucus membranes revealing evidence of marked yellowish discoloration.

Eyes reveal evidence of cataracts threatening blindness.

Teeth carious, very poor, with breath very offensive.

Chest examination reveals a free expansion with bronchovesicular breathing.

Cardiovascular System

Heart irregular revealing evidence of a myocardial degeneration with blood vessels tortorous and arteriosclerotic.

Abdomen: Palpation reveals a marked tenderness of the right hypochondrium, tenderness in the right lower quadrant.

## Summation

Diagnosis established in this case is cataracts involving both eyes threatening blindness,

ateriosclerosis, atrophic cirrhosis of the liver and chronic myocarditis.

I consider this man too ill to be incarcerated any length of time on account of his very poor state of health.
