Slattery, appearing in proper person, and the defendant having been convicted on his plea of nolo contendere of the offense charged in count two of the indictment, to wit, conspiring to injure and oppress citizens of the United States in the free exercise of their Constitutional right to vote for the selection of a Representative in the Congress of the United States, the United States having dismissed count one of the indictment, and the defendant having been asked if he has anything to say before judgment is pronounced against him, and no sufficient cause being shown or appearing to the court, and it appearing to the court that the defendant should be placed on probation, IT IS BY THE COURT

ORDERED AND ADJUDGED that the defendant be and hereby is placed on probation under the usual conditions of probation, for the period of five (5) years, without sentence of imprisonment or fine, and without costs.
