And the Grand Jurors aforesaid, on their oaths aforesaid, do further present and charge that on or about the 5th day of July, 1921, at Kansas City, Jackson County, Missouri, in the said Division and District, and within the jurisdiction of this court, one

CHARLES GARGOTTA

then and there being, did then and there unlawfully and wilfully sell to Harry Hall a certain quantity of intoxicating liquor, to-wit:
TWO OUNCES OF WHISKEY
contrary to the form of the statute in such cases made and provided, and against the peace and dignity of the United States of America.

COUNT.

And the Grand Jurors aforesaid, on their oaths aforesaid, do further present and charge that on or about the 5th day of July, 1921, at Kansas City, Jackson County, Missouri, in the said Division and District, and within the jurisdiction of this court, one

CHARLES GARGOTTA

then and there being, did then and there unlawfully and wilfully sell to Set Carson, whose true first name is to the Grand Jurors unknown, a certain quantity of intoxicating liquor, to-wit: TWO OUNCES OF WHISKEY, contrary to the form of the statute in such cases made and provided, and against the peace and dignity of the United States of America.

Fourth COUNT.

And the Grand Jurors aforesaid, on their oaths aforesaid, do further present and charge that on or about the 5th day of July, 1921, at Kansas City, Jackson County, Missouri, in the said Division and District and within the jurisdiction of this court, one CHARLES GARGOTTA, then and there being, did then and there unlawfully and wilfully, and as a second offense on the part of him, the said Charles Gargotta, he, the said Charles Gargotta having on the 26th day of April, 1921, pleaded guilty to an Information charging him with unlawful possession of intoxicating liquor, filed in the Western Division of the United States District Court for the Western District of Missouri, and was thereupon fined the sum of One Hundred Dollars and costs, POSSESS a certain quantity of intoxicating liquor, towit, One-half Pint of Whiskey, contrary to the form the statute in such cases made and provided, and against the peace and dignity of the United States of America.
