BE IT REMEMBERED, That heretofore, to-wit, on the **12** day of **Sept.** A. D. **1929**, came **Geo. P. Small Natl Pro. Agt.** and filed in my office the affidavit of himself, in the above cause.

Thereupon I issued a warrant of arrest and subpoena for the United States, and the same being duly executed on the **12** day of **Sept** A. D. **1929**, this case was heard. Present **H. L. Thomas Asst** District Attorney, also the accused, in proper person, having **Fred. W. Lewis** for his counsel.

There were sworn as witnesses for the United States **Waived**  
I held the defendant as probably guilty, and required of **him** a recognizance in the sum of **\$5000.00** with surety in same amount, to appear in the **District** Court of the United States for the said District, at **KANSAS CITY, MO.** on the **5** day of **Nov**, **1929**, which Recognizance was executed by said defendant with sureties. The accused failing to execute said recognizance, **he** was committed to the Jackson County Jail.

I annexed hereto an abstract of the testimony used on the trial.\*

I also took a recognizance of to appear in said Court and testify for said United States.

I annex hereto the said affidavit, and the warrant of arrest and subpoena and the Marshal's return thereof, the said recognizance of said accused and of said witness and the mittimus and the Marshal's return thereof.
