Testimony of Simon Partnoy

Kansas City, Missouri

Partnoy operated the wire service in Kansas City from 1939 down to May 2, 1950, when the service went out of business. The wire service was originally called the Harmony Publishing Company, but around the first of 1947 the name was changed to the Missouri-Kansas or Mo-Kan News Company. More recently the name was changed to Universal News Distributing Company.

The news distributing company has been owned by Eddy Spitz, "Snag" Klein, Thomas Lococo and the late Charles Gargotta since the fall of 1946.

Attached is a chart of Partnoy's descriptions of the wire service operating out of Kansas City.

When Partnoy went into the wire service business in 1939, he dealt with James Ragen of Continental. Ragen told him he would have to have some sort of publishing enterprise connected with the service so he could classify the company as a publishing company. It was for this reason that Partnoy started the Eagle Scratch Sheet.

When Mr. Partnoy was asked as to why Mr. Spitz should get such good arrangements with Trans-America as compared with those Partnoy had been able to get with Continental, Partnoy said that Spitz must have had some kind of influence some place.

Partnoy says that at the time he dealt with Spitz regarding the sale of the business to Spitz, he did not know that any one was associated with Spitz.

The unfinished answer of Mr. Partnoy's indicates that he thinks the stories about his being muscled in on are probably old rumors out out by Continental in an attempt to blacken their competitor.

Partnoy says that he has no knowledge of a fallow by the name of Burke being beaten up on the corner of 14th and Main in 1946. He does know that the sheriff's office asked him about it. He does not know of any Burke associated with Continental Wire Service.

The only threat that Mr. Partnoy ever received a threat made by Eddy Lenz, of Continental, after Partnoy went with Trans-America. This threat was merely a threat to put Partnoy and his associates out of business by taking their customers away from them.
