JUDGMENT AND SENTENCE

This 4th day of June, 1937, comes Maurice M. Milligan, United States Attorney, also come the defendants, James Callahan, Frank Geier, May Bartlett, Geneva Vielbig, Maude Hancher, Frank Gumminger, James Carter and Mike Cummings, in their own proper persons and with counsel; thereupon the Motion for New Trial and in Arrest of Judgment heretofore filed by the defendants James Callahan, Frank Geier, Frank Gumminger, James Carter and Mike Cummings is taken up, submitted and by the Court overruled with an exception allowed to said ruling; thereupon it appearing to the Court that the defendants James Callahan, Frank Geier, Frank Gumminger, James Carter and Mike Cummings have heretofore been tried by a Jury and found guilty as charged in counts one and two of the indictment herein, and that the defendants May Bartlett, Geneva Vielbig and Maude Hancher have heretofore entered pleas of nolo contendere to counts one and two of the indictment herein, and that said cause has been regularly continued to this date for sentence, and the United States Attorney having moved for sentence said defendants were called upon to state reasons, if any they have, why sentence should not now be pronounced upon them, and none being stated, and the Court being fully advised in the premises it is ordered that the punishment of the said defendant, James Callahan, be fixed at imprisonment in the United States Penitentiary at Leavenworth, Kansas, for a period of three (3) years on each of counts one and two of the indictment; the imprisonment imposed on count two to run concurrently with the sentence of imprisonment imposed on count one, and further that he pay a fine in the sum of Five Hundred Dollars on each of said counts one and two, said fines to be collected upon execution, without costs; that the punishment of the said defendant, Frank Geier, be fixed at imprisonment in the United States Penitentiary at Leavenworth, Kansas, for a period of two (2) years on each of said counts one and two of the indictment; the imprisonment imposed on count two to run concurrently with the sentence of imprisonment imposed on count one, and further that he pay a fine in the sum of Five Hundred Dollars on each of said counts one and two, said fines to be collected upon execution, without costs; that the said defendant, May Bartlett, be placed on probation for a period of three (3) years, without any sentence, and without costs; that the said defendant, Geneva Vielbig, be placed on probation for a period of three (3) years, without any sentence, and without costs; that the said defendant, Maude Hancher, be placed on probation for a period of three (3) years, without any punishment of the sentence, and without costs; that the/said defendant, Frank Gumminger, be fixed at imprisonment in the United States Southwestern Reformatory at El Reno, Oklahoma, for a period of two (2) years on each of said counts one and two of the indictment; the imprisonment on said counts one and two to run consecutively, and further that he pay a fine of One Hundred Dollars on each of said counts one and two, said fines to be collected upon execution, without costs; the execution of said sentences of imprisonment on counts one and two of the indictment is suspended, and said defendant is placed on probation for a period of three years; that the punishment of the said defendant, James Carter, be fixed at imprisonment in the United States Penitentiary at Leavenworth, Kansas, for a period of four (4) years on each of counts one and two of the indictment; the imprisonment imposed on count two to run concurrently with the sentence of imprisonment imposed on count one, and further that he pay a fine of Five Hundred Dollars on each of said counts one and two, said fines to be collected upon execution, without costs; that the punishment of the said defendant, Mike Cummings, be fixed at imprisonment in the United States Penitentiary at Leavenworth, Kansas, for a period of four (4) years on each of counts one and two of the indictment; the imprisonment imposed on count two to run concurrently with the sentence of imprisonment imposed on count one, and further that he pay a fine in the sum of Five Hundred Dollars on each of said counts one and two, said fines to be collected upon execution, without costs.

Thereupon the defendants James Callahan, Frank Geier, James Carter and Mike

Cummings file their separate Notices of Appeal which are allowed by the Court and ordered filed and made a part of the record herein. Bail bonds on behalf of said defendants are fixed as follows: James Callahan \$5,000.00; Frank Geier \$4,000.00 James Carter \$8,000.00; Mike Cummings \$8,000.00; cost bonds are fixed in the sum of \$250.00 as to each defendant.

Come now the said defendants Callahan, Geier, Carter and Cummings and present their bail bonds and cost bonds signed by themselves as principals and by the Central Surety and Insurance Corporation as surety which are approved by the court and ordered filed.
