4. b. NEUROPSYCHIATRIC REPORT

White, 42; Wells Revised Alpha, Form 5; surpasses 78 per cent of the inmate population. Binet Equiv, M.A. 16:2, I.Q. 101 - a very good performance. Surpasses only 20 per cent in his voluntary motor output - tapping test - a fair performance; surpasses 86 per cent in accuracy on the manipulative dexterity test - Ferguson Form Board, No. 3 - an excellent performance. With the exception of exceedingly low voluntary motor output, his clinical output is good. (Percentiles based on inmate standardization.)

Neurological examination is essentially negative.

This is a short, well nourished, fairly well developed, white man, who states that he is in good health. Asserts that he has had no previous difficulty with the law in any form and the available records do not show otherwise. He is at the present time imprisoned here for conspiracy in connection with the Vote Fraud Cases in Kansas City in 1936. States that he has been occupationally engaged as a steelworker, assistant pumper Of the Kansas City Water Co., and a street cleaning foreman.

This man reports seven years of school training. He says that he quit at the age of twelve in order to work. States that his father died when he was seven and as a result of this handicap, he was forced to curtail his education and assist in the earning of a livelihood. He states that he was victimized in the present envolvement and that circumstances through personal prejudice was responsible for his conviction. His attitude toward the institution appears to be good and it is believed he will make a good adjustment while here. He is not of the vicious type and we anticipate no custodial difficulties. There are no psychotic findings.
