2. ASSOCIATE WARDEN'S REPORT:

OUTLINE OF OFFENSE:

Convicted under indictment which indictment alleged and the evidence disclosed, that this defendant, together with others, conspired, confederated and agreed to injure and oppress certain voters in the 9th Precinct of the 12th Ward for candidates for Representatives in Congress.

STATEMENT BY INMATE:

Prior to this alleged violation, subject states, he had been employed "off and on" by the City administration. He was offered employment "at the polls" and took advantage of this opportunity to "make a few dollars". Denies that he intentionally committed any violation of the law.

SUMMARY OF IMPRESSIONS:

Is evidently a "first offender". Subject is not regarded as a vicious type. His attitude at this time toward the sentence and confinement is regarded as satisfactory and I do not anticipate that subject will present any problem whatsoever during his term of confinement. He may again enter into some type of political activity as the means of earning a livelihood; however, there is nothing at this time to indicate that he will again become a violator. QUARANTINE OFFICER indicates that subject has made an entirely satisfactory adjustment during the period in Quarantine.

#### C. ECONOMIC STATUS:

Parental Home: (cont'd) Home located at Cape Gerardo, Mo. until subject was three; at Kirksville, Mo. from 3 to 7; at Kansas City, Mo. from 7 to present time. Parents owned one family 7 room modern brick house in good repair located in residential neighborhood of Kansas City, Mo. near parks and playgrounds; parents owned satisfactory furniture and home carpeted. Children attended Christian Sunday School and Church; reared by parents in normal home; family relationships congenial. Parents

now deceased (VA3).

Personal Home: Subject never left parental home; home ties strong. Subject was rather stable socially; good industrial adjustment; never violated the law; economic status comfortable; always lived with parents until their death and then with sister; standards of living good. Subject states that he had saved \$1,500.00 at one time; has no life insurance; owns an equity in an \$8,000.00 home. Has no dependents.

Reared in normal home by parents. Fairly stable socially; social habits regular; unsophisticated in criminal attitudes and habits; first offense; moral standards good; associates with persons of good reputation; residence stable; industrial habits good; comprehends readily. Family ties close; interested in parental family; friendly, genial, frank, moderately alert, cooperative.

#### 4. (a) MEDICAL REPORT:

Physical examination reveals a white male, 50 years of age, 68 inches in height, weighing 133 pounds, and gives his occupation as clerical. He is of slender build, well nourished and well developed, and appears to be in poor physical condition. He denies the use of narcotics and there are no needle scars on his arms or body to indicate that he is a drug addict.

#### HISTORY:

No history of any serious illness or injury. Gonorrhoea in 1913. G. U. Smear is negative. Blood pressure 158/95. BLOOD TESTS HAVE NOT RETURNED FROM WASHINGTON.



PHYSICAL DEFECTS:

Heart flutters on exertion or on becoming excited. Left inguinal hernia. External hemorrhoids. Distant vision right eye 20/30, left eye 20/20. Dentists rate him as "C", all teeth extracted.

RECOMMENDATIONS:

SURGICAL REPAIR OF HERNIA. DENTAL TREATMENT. SHOULD BE REFRACTED FOR GLASSES.

THIS MAN'S GENERAL PHYSICAL CONDITION IS POOR AND BECAUSE OF HERNIA AND CONDITION OF HIS HEART HE SHOULD BE ASSIGNED TO LIGHT DUTY.

NO LIMITATIONS AS TO CELL LOCATION, RECREATION, OR DISCIPLINARY MEASURES.

4. B. NEUROPSYCHIATRIC REPORT.

White, 50; Wells Revised Alpha, Form 5. Surpasses 86 per cent of the inmate population. Binet Equiv. M. A. 17:00 I. Q. 106 - an excellent performance. Surpasses 7 per cent in his voluntary motor output - tapping test - a poor performance; surpasses 67 per cent in accuracy on the manipulative dexterity test - Ferguson Form Board No.3.- A very good performance. Low voluntary motor output and low speed on hand and eye coordination test, otherwise clinical performances consistently commendable. (Percentiles based on inmate standardization.)

Neurological examination essentially negative.

This is a well developed, well nourished male. He is of the asthenic type and makes no complaint as to the present condition of his health. Reports this to be his first clash with the law and available records do not dispute this assertion. Now stands committed to this institution under sentence of 1 year and 6 months on a charge of vote fraud in Kansas City, Mo. Gives as his occupation in civil life accountant and clerk.

This man reports that he received 12 years of academic training which is in harmony with his clinical performances. Subject is frank, genial and cooperative in demeanor, giving a well connected and coherent account of his activities, both distant and immediate. Gives no exhibition of any inherent or cultivated opposition towards society, law enforcement officials nor institutional regimen and it is believed this man will make an agreeable adjustment, affording no disciplinary problems. The examination reveals no delusional trends and discloses no psychotic symptoms.

Classification: Excellent test intelligence; emotionally adequate socially inadequate.

RECOMMENDATIONS: Minimum custody.

No additional schooling.

Farm or Road Camp possibility.

Able for manual labor.

Transfer not indicated.

Custodial Prognosis: Favorable.
