OUTLINE OF OFFENSE:

No Form 792 or other information available which indicates the circumstances of this violation.

STATEMENT BY INMATE:

Subject states he has not knowingly violated income-tax law in this or other instance. Feels he is entirely a victim of circumstances.

SUMMARY OF IMPRESSIONS:

Subject is a first offender. He does not present the appearance of a vicious type offender. He is, in this instance, probably a victim of associations and temptation. Subject has been prominent in political affairs in the State of Missouri and seems to feel that he is now the victim of activities directed toward the removal of influence of "machine politics" with particular reference to Kansas City, Missouri and the alleged dominance of certain persons in political matters in the State of Missouri. Subject's attitude at this time toward the sentence and confinement appears to be entirely satisfactory and I believe he will make an entirely conscientious effort toward an adequate institutional adjustment.

He is, however, somewhat nervous and emotional and will probably experience some difficulty in adjusting to the circumstances of confinement, particularly during the initial months of confinement. It is believed, however, that subject will put forth his best efforts toward an adjustment here. He may present some problem as a result of other inmates in the institution attempting to secure consideration from him, inasmuch as they believe subject to be influential outside the institution. For that reason, he will require segregation as to cell and work location in the institution. He perhaps should be assigned to some work which will not be too confining; however, subject's work assignment should be governed, insofar as possible, by his physical condition as reported by the Medical Staff.

Quarantine Report indicates that subject has made a very satisfactory adjustment during the Quarantine period.

Recommendations:-

TRANSFER: NONE. Benefit by such is not indicated in this instance.

SUPERVISION: MEDIUM. No institutional problem, other than as outlined above, is anticipated. Subject will make an effort toward adequate adjustment.

Furnishings owned by parents were satisfactory and the home was carpeted# Parents rented 1-family, 6-room, old-style, frame house in good repair situated in a middle-class neighborhood of Kan City, Mo. In the neighborhood were playgrounds and parks, children were sent to Sunday School and Church regularly; home discipline normal, family relations congenial Parents are deceased.

PERSONAL HOME: Subject left parental home at 27 when he was married, never returned to parental home to live, home ties with parents and brother strong.
