The Grand Jurors of the United States of America, duly and legally chosen, selected, summoned and drawn from the body of the Western Division of the Western District of Missouri, and duly and legally examined, empaneled, sworn and charged to inquire of and concerning crimes and offenses against the United States in the Western Division of the Western District of Missouri, on their oath present and charge that on or about the 27th day of September, 1923, at Kansas City, Jackson County, Missouri, in the Western Division of the Western District of Missouri and within the jurisdiction of this court, one WILLIAM S. CLIFFORD AND ANTHONY R. GIZZO, being then and there dealers in opium and its derivatives and coca leaves and their derivatives, and being persons required by the laws of the United States to register as such dealer in the Sixth Internal Revenue Collection District of Missouri, did then and there unlawfully, wilfully, knowingly and feloniously, and in violation of an Act of Congress of December 17, 1914, as amended February 24, 1919, and May 26, 1922, POSSESS for sale and distribution, a certain quantity of a derivative of opium, towit: FIFTEEN OUNCES OF MORPHINE AND ONE POUND OF GUM OPIUM, and a certain quantity of a derivative of coca leaves, towit; TWENTY-ONE OUNCES OF COCAINE, without having registered as dealers in such derivatives of their opium and coca leaves name or style and place of business with said Collector of Internal Revenue of the United States for the Sixth Internal Revenue Collection District of Missouri, and without having paid to said Collector the special tax as such dealers in said derivatives of opium and coca leaves as required by the laws of the United States of America, contrary to the form of the statute in such case made and provided, and against the peace and dignity of the United States of America.

SECOND COUNT.

And the Grand Jurors aforesaid, on their oath aforesaid, do further present and charge that on or about the 27thday of September, 1923, at Kansas City, Jackson

County, Missouri, in the Western Division of the Western District of Missouri, and within the jurisdiction of this court, one WILLIAM E. CLIFFORD AND ANTHONY R. GIZZO, did unlawfully, wilfully, knowingly and feloniously, and in violation of an Act of Congress of December 17, 1914, as amended February 24, 1919, and May 26, 1922, PURCHASE from a person or persons to the Grand Jurors unknown, a certain quantity of a derivative of opium, towit; FIFTEEN OUNCES OP MORPHINE AND ONE POUNT OF GUM OPIUM and a certain quantity of a derivative of coca leaves, towit: TWENTY-ONE OUNCES OF COCAINE the same not being in or, from the original stamped package, contrary to the form of the statute in such case made and provided, and against the peace and dignity of the United States of America.
