DEAR SIR:

I INTEND TO WRITE TO YOU IN THE EVENT YOU SHOULD BECOME GOVERNOR, SO INSTEAD OF WAITING UNTIL THEN, I AM WRITING YOU NOW NAD HOPE YOU ARE IN THE POSITION TO ANSWER MY QUESTION NOW.

WHAT IS THE LEGAL WAY I MAY GO ABOUT TO RECOVER FROM THE WIFE OF MY SLAIN ATTORNEY, A LEGAL PAPER BELONGING TO ME WHICH SHE RECEIVED THROUGH THE MAILS, HAVING BEEN MAILED TO MY LATE ATTORNEY SIX MONTHS AFTER HIS DEATH WHICH WAS THE PREMEDITATED MOTIVE FOR HIS ASSASSINATION, SO THAT HIS WIFE AND FORMER OFFICE GIRL (MRS. F. E. BURROUGHS 5721 GARFIELD HI. 3770) WOULD RECEIVE THE ANSWER TO MY PETITION INSTEAD.

AS YOU WILL KNOW, NO FURTHER MURDERS OR INCENDIARY FIRES WILL DESTROY THESE TWO FACTS: THE DEATH CERTIFICATE OF MY SLAIN ATTORNEY WILL SHOW THE DATE JUN 29<sup>TH</sup> 1932. ALMOST SIX MONTHS DIFFERENCE IN TIME. THESE TWO DATES WILL FOREVER STAND OUT AND CANNOT BE DENIED.

ATTORNEY WALTER CALVIN, REPUBLICAN, FIDELITY BANK BUILDING IS THE ATTORNEY AND ADVISOR OF THE WIFE OF MY SLAIN ATTORNEY, WHO IS ALSO THE OFFICE ASSOCIATE OF THE FORMER DISTRICT ATTORNEY, VANDEVENTER, WHO WAS INVESTIGATING THIS CASE WHEN HE LEARNED THAT IT WAS HIS OWN FRIEND AND OFFICE ASSOCIATE WHO IS THE ATTORNEY FOR THE WIFE OF MY SLAIN ATTORNY, AND WHICH HE PROMPTLY DROPPED.

IN THE THREE AND A HALF YEARS OF INVESTIGATING AND MUCH LETTER WRITING I HAVE LEARNED THAT THE WIFE OF MY SLAIN ATTORNEY HAS NO LEGAL AUTHORITY TO TRANSFER HER HUSBANDS (MY ATTORNEY) CASES TO A LAWYER OF HER OWN CHOOSING, BUT IN THIS EVENT, MRS. BURROUGHS HAD RETAINED WALTER CALVIN BEFORE THE ASSASSINATION OF HER HUSBAND (MY ATTORNEY) INSTEAD OF AFTERWARDS, WHICH ALSO WOULD NOT HAVE BEEN LEGAL.

FORMER DISTRICT ATTORNEY VANDEVENTER, POSTAL INSPECTOR JOHNSON OF KANSAS CITY, CHIEF INSPECTOR ALDRICH OF WASHINGTON AND POST-MASTER GENERAL JAMES A FARLEY ARE UNDER THE MISTAKEN IDEA THAT THE WIFE OF MY SLAIN ATTORNEY HAS BROKEN NO FEDERAL LAWS, HWEN THE FACT IS I AM PREPARED TO SHOW THAT SHE AND HER ATTORNEY AND ASSOCIATES IN THE CONSPIRACY ARE RESPONSIBLE NOT ONLY FOR FRAUD THROUGH THE MAILS USING THE FEDERAL COURT FOR THE BASIS OF THE CONSPIRACY BUT ALSO ARE RESPONSIBLE FOR MURDERS, KIDNAPING, DEATH BY SUICIDE AND A NUMBER OF OTHER DEATHS DUE TO SHOCK OF EXISTING CONDITION AMONGST THE LAW PROFESSION, YET EVERY THING IS DONE BY THE LAW ENFORCEMENT HEADED BY JAMES A. FARLEY TO SHIELD THESE TWO WHEN THE LAYMAN ARE OFTENTIMES SENT TO PRISONS ON CIRCUMSTANCIAL EVIDENCE.

I HAVE MAIL FROM JAMES A. FARLEY AND CHIEF INSPECTOR ALDRICH WHICH BEAR OUT MY CHARGES. SHREIFF MAENY OF KANSAS CITY CLAIMS TO BE THE RIGHT HAND MAN OF T. J. PENDERGAST AND CLAIMS THAT ALTHO' JAMES A FARLEY HAS RESIGNED THAT HE HIMSELF GAVE MR. FARLEY ORDERS TO STAY IN OFFICE IN ORDER THE SHIELD THE REPUBLICAN WIFE OF MY SLAIN REPUBLICAN ATTORNEY BECAUSE I WROTE THAT INTENDED TO WRITE TO THE INCOMING POST MASTER GENERAL AND LEARN WHETHER OR NOT LAWYERS WIVES ARE IMMUNE TO POSTAL, FEDERAL AND STATE LAWS.

WHEN I REPORTED THE DEATH TO BOTH LATE PROSECUTORS, PAGE AND MASTIN, THEY WERE UNDER THE IMPRESSION THAT IT WAS THE WIFE OP MY SLAIN ATTORNEY, THAT WAS TELLING THE TRUTH INSTEAD OP ME SO THE RESULT OP THIS WAS THAT ON THE SAME DAY THAT I RECEIVED DATE FOR SETTINGS FROM THE FEDERAL COURT WHICH SETTINGS WERE AGAIN MAILED TO MY SLAIN ATTORNEY AND AGAIN RECEIVED THROUGH THE MAILS BY HIS WIFE, PROSECUTOR MASTIN WAS STRICKEN AND DIED AND PROSECUTOR PAGE, THEN JUDGE PAGE, FOLLOWED SHORTLY AFTER.

THE PRESENT PROSECUTOR, GRAVES, IS NOT THE PROSECUTING ATTORNEY, BUT IT IS SECRETARY NELLE HUSTON WHO IS THE PROSECUTOR TODAY, PROSECUTOR GRAVES IS NOTHING MORE THAN A FIGURE HEAD AND THE ONLY THING THESE TWO HAVE TRIED TO DO WAS NOT TO ISSUE A WARRANT AGAINST THE WIPE OF MY SLAIN ATTORNEY BUT HAVE TRIED TO HAVE BE HELD FOR INVESTIGATION, AND THE REASON THEIR EFFORTS HAVE BEEN FRUITLESS IS BECAUSE I HAVE WRITTEN TOO MANY LETTERS ALL OVER THE UNITED STATES BEGINNING PROM THE PRESIDENT ON DOWN, AND BY THE MANY REPLIES I HAVE I KNOW THAT MRS. BURROUGHS AND WALTER CALVIN HAVE BROKEN EVERY LAW.

ROYAL COPELAND CLAIMED THAT THIS WAS A CASE FOR THE PROSECUTOR OR STATE. A SPECIAL LETTER PROM CYRUS CRANE TOOK ME BEFORE THE GRIEVANCE BOARD WHO (SEN. ARMWELL COOPER) CLAIMED THEY HAD NO JURISDICTION OVER LAWYERS WIVES AND BECAUSE OP THE SERIOUSNESS OF THE CASE I WAS ADVISED TO WAIT FOR THE INCOMING DEMOCRATIC DISTRICT ATTORNEY. I WAS HEARD BEFORE THE FEDERAL GRAND JURY BY WRITING TO THE FOREMAN AND JURORS BUT AT THIS GRAND JURY ASST. HUBBEL REFUSED TO ISSUE AN INDICTMENT AGAINST THE WIFE OF MY SLAIN ATTORNEY SAYING IT WAS THE DUTY OF THE PROSECUTORS. MY LETTER OR REPLY FROM ATTORNEY GENERAL MC KITTRICK SAID FOR ME TO SEE THE PROSECUTOR. ALTHO' I AM NOT SUPPOSED TO DIVULGE THE SECRETS OF A GRAND JURY YET THE FEDERAL GRAND JURORS ADVISED ME TO SEE THE INCOMING DISTRICT ATTORNEY BECAUSE ATTORNEY WALTER GALVIN AND U.S. ATTORNEY VANDEVENTER WERE AND STILL ARE OFFICE ASSOCIATES. I TALKED WITH THE INCOMING DISTRICT ATTORNEY (MILLIGAN) WHO GAVE ME POINTS IN LAW AND ALSO SAID THAT THE WIFE OF MY SLAIN ATTORNEY HAD NO AUTHORITY TO CHOOSE A LAWYER AFTER THE DEATH OF HER HUSBAND. THE REASON DISTRICT ATTORNEY MILLIGAN REFUSED ME PERMISSION TO GO BEFORE THE GRAND JURY WAS DUE TO A LETTER HE RECEIVED FROM PROSECUTOR GRAVES WHO I HAVE EVERY REASON TO BELIEVE WAS DUE TO THE INFLUENCE OF NELLE HUSTON, SECRETARY TO PROSECUTOR MASTIN, IN WHOSE PRESENCE I REPORTED THE THREATS AGAINST MY ATTORNEY A SHORT TIME BEFORE HE WAS SLAIN. GRIEVANCE ATTORNEY HILLARY BUSH CAN VERIFY THE STATEMENT THAT MY ATTORNEY SENT ME TO HIS OFFICE TO REPORT THE LAWYERS IN AN EFFORT TO SAVE HIS LIFE. IT WAS THEN I WENT TO THE PROSECUTORS OFFICE TO REPORT THESE THREATS WHEN NELLE HUSTON HEARD WHAT I SAID TO PROSECUTOR MASTIN.

WHY SHOULD SHERIFF MEANY, WHO CLAIMS TO BE THE RIGHT HAND MAN OF T. J. PENDERGAST TELL ME THAT ALTHO' I DID SUCCEED IN RECOVERING MY LEGAL PAPER FROM THE WIFE OF MY SLAIN ATTORNEY THAT I WOULD NEVER REACH THE COURT ALIVE? IF YOU ARE A PENDERGAST MAN YOU WOULD BE IN THE POSITION TO KNOW WHETHER A RIGHT HAND MAN OF T. J. PENDERGAST WOULD BE A KILLER. NELLE HUSTON AND SHERIFF MEANY HAVE BEEN FRIENDS FOR MANY YEARS AND I WOULD NOT BE SURPRISED IF T. J. PENDERGAST WOULD KNOW WHO SHERIFF MEANY WAS, YET AT THE SAME TIME HE SEEMED TO KNOW THAT JAMES A FARLEY WOULD BE IN OFFICE FOR ANOTHER FIVE YEARS FOR THE SIMPLE REASON OF SHIELDING THE REPUBLICAN WIFE OF MY SLAIN REPUBLICAN LAWYER.
